Volunteers must be a registered Adult leader with Boy Scouts of America.

- **Nature Director**: Supervises the teaching and program aspects of nature related programs, must be age 18. Proficient knowledge of nature related merit badges is expected. Previous teaching experience is preferred.
- First and Second Year Program Area Director: supervises the teaching and program aspects of a quality first and second year Scouting program. Must be 18 with a clear record of leadership.
